- Effective Date: This Agreement shall become effective as of the earlier of the first communication of Confidential Information by either party to the other, or execution by both parties.
- Discloser and Recipient: Each party may disclose to the other information it considers preprietary and confidential. As used herein, the party cisclosing Confidential Information is the "Disclosing Party" and the party receiving the Confidential Information is the "Recipient"

Description of the Confidential Information: The term "Confidential h formation" as used herein shall mean any and all proprietary information that is disclosed by Discloser to Recipient, including, but not limited to, matters of a technical nature such as trade secret processes or devices. techniques, data, formulas, inventions (whether or not patentable). spec fi. it ons and characteristics of products planned or being developed. and research subjects, methods and results, matters of a business nature such as information about costs, margins, pricing policies, markets, siles, suppliers, customers, product plans and marketing plans or strategies, and offer information of a similar nature that is not generally disclosed by Disclose: to the public - Confidential Information shall expressly include , m. and all information derived from the Confidential Information, including residual mental impressions of such information.

Receivent's obligations hereunder shall only extend to Confidential Information that relates to the purpose stated in Paragraph 5, or that though not related to such purpose, is nevertheless disclosed as a result of the parties' discussions, and that should reasonably have been understood by Recipient, because of legends or other markings, the circumstances of aisclosure, or the nature of the information itself, to be proprietary and cont dential to Discloser. Confidential Information may be disclosed in written or other tangible form (including on magnetic media) or by oral, visual or other means

- Use of Confidential Information: Recipient shall make use of the Contidential Information only for the following purpose Product evaluation and Customer Information
- No license granted/Return or destruction of information: Norther party acquires any intellectual property rights under this Agreement except the inmited right necessary to carry out the purposes set forth in paragraph 5 above Al. Confidential Information shall remain the property of the Disc oser. At Discloser's written request, Recipient will either destroy and certify such destruction or promptly return to Discloser all those materials which comprises Confidential Information and any copies, except a single archival copy which may be held by Recipient's attorney
- Restriction on copying: Recipient shall not reproduce, in any form. Discloser's Confidential Information unless Recipient obtains Discloser's written permission prior thereto. Any such permitted copies will be considered Confidential Information.
- Restriction on disclosure: Except as may be authorized by Discloser in scriting. Recipient will (a) not disclose Confidential Information to any not a party to this Agreement; (b) limit dissemination of Confidential Information only to its employees having a 'inced to know' and (c) have an appropriate written agreement with its employees sufficient to enable them to comply with all of the provisions of this Agreement.

Court orders: Confidential Information disclosed in response to a valid order of a court or other governmental body to the extent of and for the purpose of such order, does not represent breach of this Agreement; provided, however, that Recipient uses reasonable efforts to limit disclosure to the smallest amount reasonably possible and that Recipient shall first notify Discloser of the order and permit Discloser to seek an appropriate protective order
- 12. Right to proceed with technology: This Agreement does not restrict either party from developing, improving or marketing any products or services provided, however, that such activities are not in breach of this Agreement.
- 13. Warranties: Lach Discloser warrants to Recipient that it has the right to make the disclosures covered by this Agreement Hewever, notwithstanding any language to the contrary, the parties are not obligated to disclose any particular information to the other party. Any Confidential Information provided hereunder is on an "AS IS" basis with no war anties, implied or otherwise, including those of merchantability or fitness for a particular purpose.
- 14. Term of Agreement and survival clause: Fither party may terminate this Agreement by giving the other party written notice thereof at least thirty (30) days prior to the effective date thereof. However, the obligations of this Agreement shall survive termination or expiration for the period described in paragraph 3
- 15. Choice of law: This Agreement is made under, and shall be construed according to the laws of the state or province in which the man, office of the Discloser is located for any claim arising regarding Discloser's Confidential The parties hereby acknowledge that by virtue of this Agreement, they are conducting business in such location and consent to the jurisdiction of the courts of such location. Injunctive Relief: The parties acknowledge that monetary damages may not be a sufficient remedy for unauthorized disclosure of Confidential Information and that eather party may seek injunctive and preliminary relief to remedy any actual or threatened unauthorized use or disclosure of the Confidential Information, without requiring the posting of any bond or other security, in addition to any other damages that can be demonstrated
- Amendments: No addition or modification to this Agreement shall be effective unless made in writing and signed by both parties
