### Agreement / Terms & Conditions

#### ACKNOWLEDGEMENT/AGREEMENT:

This Agreement is between Client and Show Technology, Inc. (STI) and confirms that STI will provide audio visual services and equipment for Client event and that you have approved and understand the estimate above. Client is responsible for any lost, damaged or stolen equipment. A minimum of 72 hours notice is required on any cancellations. Full charges will be assessed for any labor, shipping and airline tickets when cancelled less than 72 hours notice before scheduled dates. In addition, a 30% restocking fee will apply on all equipment cancelled on less than 72 hours notice. All technicians require a 5-hour minimum, 10 hours constitutes a full day. Time over 10 hours will be billed at 1 1/2 times the current rate. Additional labor rates may be applied based on applicable technical requirements. Technician charges are estimates and actual hours worked will be billed.

#### TERMS:

STI will invoice Client for full payment (100%) of total quoted amount, which is due two weeks prior to event start date. Client is responsible for airfare and hotel accommodations of STI technicians. Any additional expenses are due onsite on the last day of the event (ie. Additional add on costs requested and approved by Client). A 1.6% late fee will be applied per day that payment is late.

#### **GOVERNING LAW:**

In the event of any dispute arising herein including the collection of fees, the venue of all legal proceedings shall be in the Judicial Circuit in and for Dade County, Florida and shall be governed by the laws of the State of Florida. STI shall be entitled to collection costs, court costs, and attorney fees.
