## **APPLICATIONS**

In order to be valid, the booth reservation is to be made by MAIL copy by FAX on the BOOTH RESERVATION FORM enclosed and sent to GRIMALDI FORUM along with a <u>35%</u> deposit of the total rental fee. The signature of the Booth Reservation Form and the deposit paid constitute a firm hire commitment and compel the subscriber to accept both the present general conditions and the here-after exhibition rules and regulations. No verbal or telephone agreement will commit GRIMALDI FORUM, unless confirmed in writing.

The remaining rental fee is to be settled by <u>25 September 2014</u> at the latest. Non-payment by this stated deadline will lead to the cancellation of the right to use the booth, without reimbursement of the deposit paid.

## STAND ALLOCATION

Site allocations will be attributed following strict reservation order of arrival and when full payment will be received. Once locations have been attributed no change of location will be possible without GRIMALDI FORUM's written agreement.

The exhibition floor plan presented in this document is non-contractual. It is subject to acceptance by the security Authority and its Fire & Safety Services.

The organizer reserves the right to modify the required surfaces booked by the exhibition company together with the corresponding invoicing

However, it does not mean that the exhibitor can ask for the cancellation of his participation.

The organizer will be the only responsible for the allocation of stands.

The possible complaints in the attributions of stands to exhibitors have to be sent in writing to the organizer within 7 days after reception of the allocation floor plan.

The expiration of the deadline of seven days as from the sending of the proposal of location, is worth acceptance of the exhibitor, in the allocated area.

An Exhibitors' Manual will be sent to every registered Exhibitor upon reception of a <u>35%</u> deposit. This file will allow the exhibitors to order additional equipment for the booth.

#### **EXHIBITION RULES AND REGULATIONS**

These Rules and Regulations shall apply to the contractual arrangements between the Company and GRIMALDI FORUM and are accepted by the Company upon completion and signature of the booth reservation form.

## DEFINITION

**GRIMALDI FORUM** Means the company which has been entrusted with the

general logistics and organisation of the Exhibition.

Means the company which signed the booth reservation form Company

Exhibition Means the Exhibition to be held during the "83rd ICPO-

**INTERPOL General Assembly** 

Booth Means the Booth with the specification defined in the

administrative conditions

Intellectual Property Means patents, registered designs, applications of any of

> those rights, trade and business names and registered and unregistered trademarks and service marks, copyrights, know how, rights in designs and inventions and any rights of the same or similar effect or nature in each case in any jurisdiction

**Parties** 

GRIMALDI FORUM and the Company are known collectively as

the Parties and individually as the Party

INTERPOL Means the International Criminal Police Organization, an

international organization governed by public international law benefiting from host agreement with the French

Government.

INTERPOL is a third party to the Agreement.

Nothing in the present Agreement shall be construed as

INTERPOL's waiver of its immunity from jurisdiction.





#### **AGREEMENT**

The entire agreement between GRIMALDI FORUM and the Company hereafter referred to as the agreement, include the booth reservation form, the General Conditions & the Exhibition rules and regulations.

No Agreement shall be made between the Parties before INTERPOL's approval (even if the Company already signed the booth reservation form). In case of INTERPOL's refusal, there will be no Agreement (even if the Company already signed the booth reservation form) and GRIMALDI FORUM will refund any deposit made by the Company and neither INTERPOL nor GRIMALDI FORUM shall be held liable for any other amounts or expenses.

#### **PROVIDED SERVICES**

By the Agreement, GRIMALDI FORUM provides to the Company the following services:

- Rent and use of Booth as described in previous documents during the Exhibition and during assembling and dismantling
- Information and coordination services during the assembling and dismantling of Booth and during the Exhibition.
- Care-taking of public areas, excluding the booths which are under the Company's responsibility.
- Cleaning of public areas of the Exhibition hall.
- Provides an exhibitors manual in order to rent additional services like IT, handling....

#### **EXHIBITING FEES**

The exhibiting fees for the services provided by GRIMALDI FORUM are defined in the booth reservation form and paid by the Company as follows:

Payment of the 35% deposit in euros should be made during 10 working days after signed the contract. Last 65% in euros should be made before 25 September 2014.

# BALANCE - FINAL INVOICE

At the end of the event, a final invoice is issued by GRIMALDI FORUM, which details all of the services (rental and associated services) supplied during the event.

The Company will have a period of 15 working days as from the date on which the invoice is drawn up in which to contest any items on the invoice, providing proof in all cases. The parties agree to handle and resolve such disputes within a period of one month after they first arise.

The balance of the sums payable to GRIMALDI FORUM (as shown on the final invoice) is payable within 30 days following the issuing of this invoice. The Company may not use a request for a modification to the invoice in order to delay the payment due date, unless the invoice does not correspond to the order forms and/or to the Estimates signed by the Company.

#### TAXES - DUTIES

The Company must be in compliance with all taxes and miscellaneous contributions applicable in Monaco.

GRIMALDI FORUM can provide the companies with the address of a fiscal representative in order to carry out the various formalities needed to recover VAT.

#### LOCAL AND SITE REGULATION

GRIMALDI FORUM has the authority to demand removal / change or cancel participation of any structure which is not in accordance with the chapter here named "company's obligations". The decision of GRIMALDI FORUM will be final and binding.

#### FORGERY

The Exhibitor has to deal personally with the intellectual protection and/or the manufaction of the materials, the products, services and brands exposed correspondingly in the current legal and statutory requirements, the Organizer being released from any responsibility in this matter in particular in case of dispute with another Exhibitor or visitor.

## ENTRY TO EXHIBITION

Access to the Exhibition will be possible only to regularly registered conference and Exhibition participants as well as accredited media.

GRIMALDI FORUM or INTERPOL reserves the right to forbid access to, or to remove any person whose attitude or appearance is considered to be incompatible with the image of the establishment and the quality of the premises, or who refuses to conform to the safety rules for the premises.

Unless authorised beforehand and in writing, it is strictly forbidden to bring animals inside the GRIMALDI FORUM.

#### **EXHIBITORS' MANUAL**

All the information concerning the details of the participation of the company to this exhibition

are supplied after allocation of the stands in a document called "exhibitors' manual" sent to every registered exhibitor.

The Exhibitor commits also to respect the conditions of insurance, safety rules and prevention of the custom formalities ...as well as the conditions for the set-up of stands.

#### **CUSTOMS**

It will be up to every exhibitor to achieve customs formalities for all material, equipment and products coming from foreign countries. The organizer cannot be held responsible of the difficulties which could arise during these formalities.

The exhibitor thus protects the organizers from any disclaim and/or complaints and will indemnify them for any damage which they would undergo because of the non-compliance with the necessary customs formalities.

#### MEDIA COVERAGE

Exhibitors, who do not wish to be filmed or photographed by local or international media having access to the Exhibition, should expressly disclose this on the booth reservation form.

#### THE COMPANY'S OBLIGATIONS

During the continuance of the Agreement, the Company agrees with GRIMALDI FORUM:

- Arrival: the Company shall be solely responsible for the transportation of its material and products to the Exhibition and its storage without prejudice to any assistance that may be provided by GRIMALDI FORUM
- Installation: to install at its own risk and cost the Company's material and products during the permitted times;
- Repair: to maintain and keep in good and substantial order and condition the Booth during the Exhibition;





- Local and site regulations: the Company shall abide by the local and site regulations with respect to law and order, safety and security. GRIMALDI FORUM will take appropriate action against those who do not comply with regulations.
- Fire precautions and equipment and gas installations: to comply with all requirements of the appropriate fire authority and the request and recommendations of GRIMALDI FORUM in relation to fire precautions:
- All gas installations are strictly forbidden within the building.
- Apart from the delivery area for level -4 and its access, no vehicle with a running combustion engine is authorised in the building.
- The smoking bans must be strictly enforced, including during the assembly and dismantling periods.
- The use of fireworks and firecrackers for entertainment features must be the subject of a special examination by the Technical Committee.
- The use of naked flames is forbidden during events.
- Any event including the use of smoke machines must be the subject of a special examination by the Grimaldi Forum's Fire Safety Department.
- Except in the event of an explicit and fully justified request, all exits must remain unobstructed.
- The equipment made available in the exhibition areas or on stage must under no circumstances adversely affect the correct operation of the safety equipment.
- All M0, M1, M2, M3, M4 fire reactions must be justified by valid certificates, issued by a laboratory approved in France or by the conformity mark for the N.F. standard
- The use of awnings may only be authorized for use in the event following the submission of a special request
- More generally, the Company agrees to comply with any restriction, regulation or policy imposed by GRIMALDI FORUM and/or INTERPOL if GRIMALDI FORUM and/or INTERPOL consider the use of the Company's Booth or advertising insert could be considered as being damaging to INTERPOL's name or interests,
- Name and interests of INTERPOL: to respect INTERPOL's image and name and not to do anything that is likely to prejudice INTERPOL's reputation, image or interests;
- Exhibiting products: not to bring into the Exhibition exhibiting products not allowed by GRIMALDI FORUM and/or INTERPOL;
- Alterations: not to make any alteration to the Booth;

- At the end of the Exhibition, the Company shall return the Booth in substantially the same condition as the Company found it;
- GRIMALDI FORUM's Access:
- To allow GRIMALDI FORUM and all persons authorized by GRIMALDI FORUM with all necessary materials to enter and work in the Booth to exercise any of GRIMALDI FORUM's rights under the Agreement;
- -No Subletting: the Company is not permitted to assign, sublet or apportion the whole or any part of the Booth allotted to it.
- -The Company must not have responded to a call for tenders currently organized by INTERPOL without prejudice to future indications provided by INTERPOL
- -The Company must not respond to a call for tenders organized by INTERPOL within the six months following the Exhibition without prejudice to future indications provided by INTERPOL;
- -The contribution and the activity of The Company must be compatible with the principles, goals and activities of INTERPOL.
- -The Company must answer requirements of morality, notoriety and reliability.
- -The exhibitor commits not to cause any embarrassment (sound, smell ....) towards the nearby exhibitors nor to disturb the organization of the exhibition

#### NON SOLICITATION

INTERPOL and the Company shall refrain, except in the case of a prior written agreement, from directly or indirectly engaging an employee of the other Party assigned to providing the services covered by this Agreement, even if any such sollicitation is at the initiative of the said employee, and/or from taking that employee into its service under any status whatsoever.

The present Article shall apply throughout the implementation of this Agreement and for a period of two (2) years following its completion.

Should one of the Parties fail to respect this obligation, it undertakes to compensate the other Party by paying an indemnity equal to twelve (12) months' basic salary of the employee concerned.

## CONFIDENTIALITY

The Company shall regard as strictly confidential and treat as such any knowledge, information and documents

given and communicated by INTERPOL or GRIMALDI FORUM within the framework of the presents and relating to INTERPOL, whatever their nature and their media may be.

The Company undertakes not to reveal or let reveal directly or indirectly, entirely or partly, the aforementioned information to any third party.

The Company shall take all required measures, in particular with regard to its personnel, for the permanent and rigorous respect of this obligation. The Company undertakes not to use Confidential Information for any purpose other than the execution of this contract, and more particularly, shall not make any reference to INTERPOL in any publicity without prior and written acceptance of INTERPOL.

#### LIABILITY IN CASE OF CANCELLATION

Neither INTERPOL nor GRIMALDI FORUM may under any circumstances be held liable for any cancellation of the Event or any of the consequences of such a cancellation.

In the event of cancellation by the Company, the deposits required will remain payable to GRIMALDI FORUM.

#### MARKETING

The Company may announce, publicize and promote its participation in the Exhibition in a manner and form previously approved in writing by GRIMALDI FORUM and/or INTERPOL will not have to motivate their refusal.

GRIMALDI FORUM shall advertise the Company's Booth on all such media installed at the Exhibition and in other promotional material and brochures produced by or on behalf of GRIMALDI FORUM in the sole discretion of GRIMALDI FORUM.

## INTELLECTUAL PROPERTY

The Company shall not without the prior consent of FORUM GRIMALDI or INTERPOL:

- use any Intellectual Property which belong to or are used by GRIMALDI FORUM or INTERPOL
- or use any trade mark licensed to or registered in the name of GRIMALDI FORUM or INTERPOL.





The Company hereby grants GRIMALDI FORUM a non-exclusive right to use and publish the Company's name and trade marks in connection with the Exhibition and in any promotional document.

No party shall have or acquire any right, title or interest in any licensed material, intellectual property right, mask work, trade secret or know-how of the other party under this Agreement.

#### INSURANCE

The Company shall subscribe with a reputable insurance company and provide to GRIMALDI FORUM, 15 days before the event, a copy of:

- Its civil and professional liability policy covering any loss, damage or injury to any person or property whatsoever during or because of the Exhibition or any journey related to the Exhibition.
- An insurance policy to cover all its property and exhibiting products, which are not covered by GRIMALDI FORUM's policy, including in particular the Booth.

#### LIMITATION OF RESPONSIBILITY

Except in the case of negligence, GRIMALDI FORUM assumes no liability for damage to property of the Company, its agents, representatives, employees, invitees, guest or other persons.

The Company, and its insurance company, renounce to take recourse against GRIMALDI FORUM and undertake to subscribe the insurance policies defined in the article INSURANCE.

Except in the case of negligence, no liability shall arise against or attach to GRIMALDI FORUM in any circumstances whatsoever in respect of injury or damage to any person or company including (but not only) the Company and its employees and clients or to any property including (but not only) the Booth or to the trade or business of any person or company or in respect of any economic or consequential loss and whether incurred directly or indirectly by reason of any statutory authority or any statutory undertaking to or in respect of any part of the Conference Centre.

The Company and GRIMALDI FORUM acknowledge that INTERPOL is a third party to the present Agreement and that the Agreement does not create any obligation whatsoever for INTERPOL

The Company as well as its insurance company(ies) renounce to take any action against INTERPOL for any damage, loss or injury whatsoever incurred in relation with

the present Agreement.

Shall the competent judge/tribunal dismiss the previous provision, INTERPOL's liability shall have the same extent/limitations as that from GRIMALDI FORUM

Besides, in no event shall INTERPOL be liable for any indirect, incidental, punitive, special or consequential damages, or damages for loss of profits, revenue or use incurred by the Company or any third party.

#### **TERMINATION**

If any part of the Exhibiting Fees or any other payment due under this Agreement is unpaid after becoming payable or if any obligation on the Company's part shall not be performed, then GRIMALDI FORUM shall be entitled upon written notice to the Company to immediately terminate this Agreement, without prejudice to any claim by GRIMALDI FORUM in respect of any previous antecedent breach of any obligation.

In case of cancellation of the General Assembly and/or Exhibition decided by INTERPOL for any raison, the Agreement will be terminated at the date of the said decision and GRIMALDI FORUM will refund any deposits made by the Company as part of the Exhibiting Fee and any Exhibiting Fees already paid by the Company and will not be held liable for any other amounts or expenses incurred by the Company in other matters.

In respect of the contract between GRIMALDI FORUM and INTERPOL for the Exhibition's organisation, INTERPOL has the right to terminate the said contract at any time without motivation and without any fault on GRIMALDI FORUM's part. In this case, the Agreement between GRIMALDI FORUM and the Company will be automatically terminated and GRIMALDI FORUM will refund any deposits made by the Company as part of the Exhibiting Fees and any Exhibiting Fees already paid by the Company, Neither GRIMALDI FORUM nor INTERPOL shall be held liable for any other amounts or expenses incurred by the Company.

Without prejudice to their other rights, GRIMALDI FORUM and/or INTERPOL shall be entitled upon written notice to the Company to immediately terminate the Agreement between GRIMALDI FORUM and the Company for any act or practice of the Company that is likely to prejudice INTERPOL's reputation, image or interests. In this case, the Agreement between GRIMALDI FORUM and the Company will be automatically terminated and GRIMALDI FORUM will refund any deposits made by the Company as part of the Exhibiting Fees and any Exhibiting Fees already paid by the

Company. Neither GRIMALDI FORUM nor INTERPOL shall be held liable for any other amounts or expenses incurred by the Company.

In case of termination of the Agreement, any licenses eventually granted by either Party to the other hereunder shall immediately terminate.

#### **FORCE MAJEURE**

GRIMALDI FORUM shall not be liable for any delay in performing or for failure to perform any obligations under the Agreement if the failure is caused by an Event of Force Majeure (acts of God; outbreak of hostilities, riots, civil disturbance, acts of terrorism ; fire, explosion, flood, fog or bad weather; power failure, failure telecommunications lines, failure or breakdown of plan, machinery or vehicles; theft, malicious damage, strike, lockout or industrial action of any kind, health measures).

Any such delay or failure shall not constitute a breach of the Agreement and the time for performance shall be extended by a period equivalent to that during which performance is so prevented.

If any Event of Force Majeure shall continue for a period of 30 (thirty) working days or more, then the Parties shall be entitled to terminate the Agreement forthwith upon written notice.

#### **DOMICILIATION AND APPLICABLE LAW**

The Parties elect domicile at their respective registered offices indicated in the booth reservation form. All notifications must be sent to this address.

The applicable law is the law of Monaco.

Any dispute arising from the implementation or interpretation of this Agreement, and which could not be resolved by mutual agreement between the Parties, will be submitted to the competent court of Monaco.


